



## Waiver of Liability, Assumption of Risk, and Indemnity Agreement

### Acknowledgment and Assumption of Risk

By signing below, I recognize and acknowledge that the premises (the "Premises") owned and operated by Saint Francis Wolf Sanctuary, Inc. ("SFWS") hold potentially dangerous domestic and non-domestic animals, and that **entering onto the Premises is hazardous and involves inherent risks**, including, without limitation, bruises, scrapes, abrasions, bites, scratches, infections, broken bones, trauma, illness, fear and mental anguish, property damages, and death. I hereby assert that I understand the risks and **my entering onto the Premises and/or participation in any activity on the Premises is voluntary and that I personally assume any and all risks**, whether foreseen or unforeseen.

### Release, Waiver and Indemnity Agreement

The undersigned hereby releases, waives, forever discharges, holds harmless, and agrees to indemnify SFWS and its officers, directors, employees, and volunteers; (collectively, the "Releasees") from any and all liabilities, claims, demands, costs, expenses (including attorney's fees), compensation, damages, losses, or debts (collectively, "Damages") which the undersigned, or the undersigned's minor children or any and all other minors in the care or custody of the undersigned (collectively, the "Minors"), or the undersigned's heirs, executors, administrators, representatives, and assigns, incur or suffer at any time, either directly or indirectly, arising out of or in connection with the undersigned and/or the Minors entering onto the Premises and/or participating in any activity on the Premises, regardless of the cause of such Damages, **including, but not limited to, the negligence of the Releasees.**

The undersigned covenants and agrees, for the undersigned and the undersigned's Minors, heirs, representatives, and assigns, never to sue, assert or otherwise maintain any claim against the Releasees arising from or in any way connected with the undersigned's or Minor's access to or participation in any activity on the Premises, and agrees to indemnify, defend, save, and hold harmless any and all of the Releasees from any and all Damages which may be incurred as the result of such claim(s).

### Severability

The undersigned further expressly agrees that the foregoing Acknowledgment and Assumption of Risk and Release, Waiver, and Indemnity Agreement is intended to be as broad and inclusive as permitted by the laws of the State of Texas, and that if any portion thereof is held to be invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
